1. INTRODUCTION

This privacy statement covers the website www.maxainasia.com and any other related websites that are registered and operated by the Company.

Maxain Markets Limited is a company registered in the Saint Vincent and the Grenadines under registration number 25526 BC 2019.

Maxain Markets Limited (hereinafter referred to as 'MAXAIN' or the 'Company') is a brokerage firm that operates globally.

2. APPLICATION

In order to open an account with MAXAIN, clients must first complete an online application form attaching the required documents. In the event that the system is down, clients will be requested to submit the form and documents manually. By completing the application form you are requested to give private information in order to enable the Company to evaluate your application and comply with the Laws and Regulations governing the provision of financial services. This information is also used to contact you about the Company's services.

3. PERSONAL IDENTIFIABLE INFORMATION

We do share Personally Identifiable Information with 3rd Parties solely for statistical purposes and in an effort to improve the Company's marketing campaign and to the extent allowed by the Terms and Conditions already accepted by you. This information includes but is not limited to personal details such as name, address, date of birth, contact details, employment details, assets and liabilities and other necessary financial information. From time to time we may also request further information to help us improve our services to you.

4. AGENTS

We use a card processing company for deposits and withdrawals to and from your account. This company does not retain, share, store or use personally identifiable information for any other purposes.

5. PRIVACY

Any personal information you provide will be treated as confidential and shared only within the Company, its affiliates and its business partners and will not be disclosed to any 3rd party except under any regulatory or legal proceedings or to 3rd parties that solely provide statistical services to the Company to improve its marketing campaign.

Website tracking systems may also collect data detailing the pages you have accessed, how you discovered this site, the frequency of visits and so on. The information we obtain is used to improve the content of our website and may be used by us to contact you, by any appropriate means, and to provide you with any information we believe may be useful to you.

You can remove persistent cookies by following directions provided in your Internet browser's "Help" file.

We set persistent cookies for statistical purposes. Persistent cookies also enable us to track and target the location and interests of our users and to

enhance the experience of our services on our site. If you reject cookies, you may still use our site.

Some of our business partners use cookies on our site. We have no access to or control over these cookies.

10. SECURITY AND PROTECTION OF YOUR PERSONAL INFORMATION

The personal information that you provide in connection with registering as a user of the Site or of the Services, is classified as Registration Information. Registration Information is protected in many ways.

You can access your Registration Information through a password selected by you. This password is encrypted and known only to you. Your password must not be revealed to anyone.
